Course Description:

This class will study poverty around the world in a comparative perspective. The focus will be on concepts and measurement of poverty, causes of poverty, and policies that are intended to reduce poverty. The class will have three main parts. The first part will examine alternative concepts of poverty and how they have evolved over time. It also will explore approaches to the measurement of poverty. The next two parts of the class will study poverty in the U.S. and in developing countries.

Readings: Students are expected to read one chapter or article per class, and to come to class prepared to discuss the material.

Daily clicker questions: At the beginning of each class, I will ask several multiple choice questions related to the readings for that day. There will also be occasional clicker questions during lecture. Your two lowest daily scores will be dropped. No exceptions will be made.

Discussion section: I will run a discussion section so that we can have an opportunity to discuss the material in more depth and to see a couple of documentaries. I will not lecture. Attendance is required, and you must bring a <u>typed</u> question with your name and student I.D. to each class.

Poverty data project: Students will be expected to assemble data on poverty in a single country, present it in tables and graphs, and write a brief description of the data. Guidelines will be distributed in advance.

Exams and Quiz: A quiz is scheduled for Thursday of week 3 (April 18). The mid-term exam is scheduled for Thursday of week 5 (May 2). The final exam will be cumulative, and will be held on Thursday, June 13, 8-11am.

Academic Honesty: Any student found committing plagiarism, not handing in original work of his/her own, or cheating in any way, will be given an <u>F in the course</u> and will be subject to disciplinary action by the University.
